1 TERMS AND DEFINITIONS

1.1 The following terms and definitions are used in this Code of Academic Integrity:

3. GENERAL PROVISIONS

- 1.1 NpJSC "Astana Medical University" (hereinafter referred to as the University) declares intolerance to any manifestations of violation of the principles of academic integrity.
- 1.2 The University Code of Academic Integrity (hereinafter referred to as the Code) is a guide and set of corporate rules and principles for participants in the educational process: faculty, administrative staff, academic and support staff, students and their legal representatives (hereinafter referred to as participants).
 - 1.3 This Code establishes the basic concepts and principles of academic

integrity, the goals and objectives of their application, the rights and obligations of participants in the educational process, as well as defines the types of violations and the procedure for taking disciplinary measures.

1.4 The provisions of this Code may be revised in the event of changes in the regulations governing educational activities in the Republic of Kazakhstan, the Charter of the University and its development strategy, vision andrevision of educational programs.

1.5 The provisions of this Code are developed in accordance with the current legislation of the Republic of Kazakhstan.

4. GOALS, OBJECTIVES, PRINCIPLES AND TRANSPARENCY

- 4.1 The main purpose of this Code is to establish regulations for academic integrity, create an academic atmosphere, and ensure that participants in the educational process comply with accepted standards and norms of academic policy and academic integrity.
 - 4.2 Key objectives in the field of academic integrity:
 - 4.2.1 assistance in improving the quality of training of specialists;
 - 4.2.2 creating an enabling environment to ensure academic integrity.
 - 4.3 The principles of academic integrity are:
- 4.3.1 conscientiousness is an honest, decent performance of evaluated and unappreciated types of educational tasks by participants in the educational process;
- 4.3.2 protection of the rights of the author and his legal successors recognition of the authorship and protection of works that are subject to copyright, through the correct transmission of someone else's speech, thoughts and indication of sources and information in the evaluated works;
- 4.3.3 openness transparency, mutual trust, open exchange of information and ideas between participants in the educational process; respect for the rights and freedoms of participants in the educational process the right to free expression of opinions and ideas;
- 4.3.4 equality each participant in the educational process ensures compliance with the rules of academic integrity and equal responsibility for their violation.
 - 4.4 Transparency of the educational process:
- 4.4.1 the organization of the educational process at the University is based on the principles of openness, transparency, objectivity and ethical behavior;
- 4.4.2The University administration implements measures to ensure transparency, openness and accessibility of the educational process.

5. TYPES НАРУШЕНИЙ OF ACADEMIC INTEGRITY VIOLATIONS

5.1 Types of violations of academic integrity of students:

 - 7) a manifestation of corruption.
 - 5.2 Types of violations of academic integrity by faculty members:
 - 1) plagiarism.
 - 2) collusion.
 - 3) deception.
- 4) falsification of estimates data of the work being evaluated, and documents:
 - 5) sending responses to the evaluated works.
 - 6) manifestation of corruption;
 - 7) abuse of authority.
- 5.3 Types of violations of academic integrity by employees of educational support and administrative staff:
 - 1) collusion.
 - 2) deception.
- 3) falsification of estimates, data оцениваемой of the work being evaluated, and documents;
 - 4) sending responses to the evaluated works.
 - 5) manifestation of corruption signs;
- 6) abuse of authority.5.4. Works that violate the principles of academic integrity are not accepted or evaluated. In order to avoid plagiarism, all types of written works (term papers, theses, dissertations, etc.) of students are tested to identify the degree of originality of the work, including through specialized information systems and databases.

6. RIGHTS AND OBLIGATIONS OF PARTICIPANTS IN THE EDUCATIONAL PROCESS WITHIN THE FRAMEWORK OF ACADEMIC INTEGRITY

- 6.1 Participants in the educational process have the right to:
- 6.1.1. get acquainted with this Code;
- 6.1.2. resolve conflict situations that arise in the process of identifying violations of academic integrity, in accordance with this Code, Academic Policy and Internal Regulations of the University, as well as in accordance with the current legislation of the Republic of Kazakhstan;
- 6.1.3. protect the interests of participants in the educational process on the part of the University, to preserve confidentiality during the proceedings on the fact of violation of academic integrity. Participants in the educational process

should not be harmed if they refuse to participate in processes that contradict the principles of academic integrity, or for conscientiously providing information that an actual or potential violation of academic integrity has occurred or may occur in the future;

- 6.1.4. receive assistance in learning how to use licensed information programs to check written works, dissertations, and projects for originality.
 - 6.2 Participants in the educational process are deceived:
- 6.2.1. prevent any possible violation of the norms of this Code and ensure their strict compliance, including in accordance with job descriptions and internal regulations;
- 6.2.2. conduct an expert review of academic and research papers (essays, term papers, essays, practice reports, theses and dissertations, scientific articles) of students for compliance with the principles of academic integrity;
- 6.2.3. inform the University management (rector, vice-rectors) and parents or other legal representatives about each case of violation of the Code;
- 6.2.4. promote the implementation of the principles of academic integrity in the practice of their work;
- 6.3 In addition to the duties specified in clause 6.2 of this Code, the University faculty members are required to:
- 6.3.1. reflect and comply with the disciplines reflected in syllabuses and inform students about the forms of border control and assessment criteria; be responsible for filling out the pedagogical (electronic and paper) journal;
- 6.3.2. conduct explanatory work with students before they perform control measures on the observance of academic integrity;
 - 6.3.3. inform the management about each case of violation of the Code.
- 6.4 In addition to the responsibilities specified in clause 6.2 of this Code, the University's teaching, support, and administrative staff are required to continuously maintain an environment of academic integrity. The AP is responsible for explaining the University's regulatory documents to faculty members, the University staff and students, and coordinates the implementation of measures provided for in this Code.

7. RESPONSIBILITY OF PARTICIPANTS IN THE EDUCATIONAL PROCESS

- 7.1 In case of violation of the provisions of this Code, the issue of liability is submitted for consideration to the Disciplinary Council, the Disciplinary Commission of the University by sending a submission with the attachment of relevant documents on the nature of the violation.
- 7.2 Participants in the educational process are subject to disciplinary liability for violating the principles of academic integrity and the provisions of this Code.
- 7.3 The University's academic and support staff, and administrative staff are responsible for identifying and preventing academic dishonesty.

- 7.4.1 In addition to violations specified in paragraphs 5.2 and 5.3 of this Code, academic staff, auxiliary and administrative staff shall also be held liable in cases: dissemination of information on the educational process that affects the assessment results of students and teaching staff.
- 7.4.2 failure to perform official duties aimed at ensuring the educational process.
- 7.5 For violation of the provisions of this Code, the following disciplinary penalties may be applied to participants in the educational process and recorded in their personal file:
 - 7.5.1. note:
 - 7.5.2. reprimand (written);
 - 7.5.3. a severe reprimand.
 - 7.5.4. deduction from the University;
 - 7.5.5. dismissal from the University.
- 7.6. A disciplinary penalty is imposed by a decision of the Disciplinary Committee.
- 7.7. A disciplinary penalty in the form of expulsion and dismissal from the University is issued by the order of the rector/authorized person.
- 7.8. For the purpose of educational impact, the decision to apply a disciplinary penalty must be announced among students, as well as brought to the attention of the student's parents.
- 7.9. Participants in the educational process are subject to expulsion/dismissal from the University:
 - 7.9.1. for the appearance of corruption;
- 7.9.2. for participation in hacker attacks, disabling (hacking), as well as the use of other actions aimed at destabilizing and normal operation of the University's information systems, confirmed by relevant documents of law enforcement and judicial authorities;
- 7.9.3. for involvement (action/omission) and / or establishing the fact of increasing the score when passing exams (or other tests) in the University's information systems.
- 7.10 At the same time, the basis for deduction is the supporting documents/facts/data of the relevant structural unit (s) of the University about the change/increase in points when passing exams (or other tests) in the University's information systems for students.
